1. (U) **SITUATION.**

1.A. ~~(S//REL)~~ **ENEMY FORCES.** THE PRIMARY THREAT WITHIN THE OPERATION BEDROCK AREA (A.K.A. THE QUARRIES AREA - SEE ENCLOSURE 1) IS AQI. IT IS ASSESSED THAT AQI USE THIS AREA AS A TRANSITORY LOCATION FOR HIGH VALUE LEADER MEETINGS, AQI TRAINING, CACHE SITES AND AS A STAGING AREA. HISTORICAL ACTIVITY AND CURRENT THREAT REPORTING INDICATES THAT AQI USES A LOCAL INFORMANT NETWORK TO PROVIDE EARLY WARNING OF CF ACTIVITIES. DURING PREVIOUS OPERATIONS, CF ENCOUNTERED A LAYERED SECURITY ZONE CONSISTING OF BURIED IEDS, AAA AND SMALL ARMS FIRE. AQI AND THE LOCAL CRIMINAL ELEMENT USE THIS AREA FOR BLACK MARKET ACTIVITIES AS WELL AS HIGH JACKING AND KIDNAPPING TO FUND OPERATIONS.

1.A.1 ~~(S//REL)~~ MOST LIKELY ENEMY COURSE OF ACTION: EXPECT AQI LEADERSHIP TO DISPERSE TO MULTIPLE LOCATIONS UNTIL CF OPERATIONS ARE COMPLETE. THESE LOCATIONS INCLUDE AMERIYAH / FALLUJAH, SA'AB AL BOUR / TAJI / TARMİYAH, ZAIDON, YUSIFIYAH, ABU GHRAIB AND SAMARRA. SOME LOWER LEVEL FIGHTERS WILL REMAIN TO RESIST COALITION FORCES AND WILL BLEND INTO THE POPULATION IF FIGHTING IS NOT AN OPTION. THESE FIGHTERS WILL MONITOR CF ACTIVITIES, MOVEMENTS, AND TTPS. CRIMINALS WILL TEMPORARILY HALT MOST BLACK MARKET ACTIVITIES UNTIL CF DEPART.

1.A.2. ~~(S//REL)~~ MOST DANGEROUS ENEMY COA: EXPECT AQI TO USE ITS INFORMANT NETWORK TO PROVIDE EARLY WARNING AND SHIFTING ITS SANCTUARY TO A SINGLE LOCATION. CURRENTLY THE MOST PERMISSIVE AVAILABLE SANCTUARY IS ASSESSED AS SAMARRA AS THIS AREA PROVIDES THEM A MAJORITY POPULATION THAT WILL SUPPORT THEM AND AN UNSTABLE ENVIRONMENT WHICH THEY CAN EXPLOIT. CRIMINAL ELEMENTS WILL COOPERATE WITH AQI STAY-BEHINDS TO ATTACK CF TARGETS OF OPPORTUNITY. SUICIDE ATTACKS IN THE AREA WILL FOCUS ON CF.

FROM NOW UNTIL SEP 07 MNC-I FORCES WILL CONDUCT AGGRESSIVE OFFENSIVE OPERATIONS TO SECURE THE IRAQI POPULACE, REDUCE SECTARIAN VIOLENCE, DEFEAT INSURGENT NETWORKS AND

WHILE THE CORPS MAIN EFFORT AND FOCUS OF THE PLUS-UP FORCES REMAINS BAGHDAD AND THE BAGHDAD BELTS, MNC-I IS EXPANDING ITS OPERATIONS TO DENY THE ENEMY FREEDOM OF MOVEMENT AND SANCTUARY IN AREAS CF HAVE TRADITIONALLY HAD MINIMAL PRESENCE, WHILE MAINTAINING THE PROGRESS IN CURRENT AREAS OF OPERATIONS.

O/A 14 JUL 07, A JOINT SPECIAL OPERATIONS AREA (JSOA) WILL BE CREATED GIVING CJSOTF-AP RESPONSIBILITY FOR ALL COLLECTION AND OPERATIONS IN THE QUARRIES AREA (SEE ATT 1). CJSOTF-AP WILL COORDINATE CLOSELY WITH MNF-W, MND-B, MND-N AND OCF-I TO COLLECT ON AQI REACTIONS TO CF OPERATIONS IN AND NEAR THE QUARRIES AND TO DEVELOP TARGET PACKAGES FOR KINETIC STRIKES AND SEARCH AND ATTACK OPERATIONS IN PHASES III AND IV. CONCURRENT WITH THE INITIATION OF KINETIC STRIKES WITHIN THE QUARRIES AREA MND-N WILL ESTABLISH POSITIONS TO CONTAIN AQI NORTH AND EAST OF THE QUARRIES AND MND-B WILL ESTABLISH POSITIONS TO CONTAINS SOUTH OF THE QUARRIES IN ORDER TO PREVENT WITHDRAWAL OF ENEMY FORCES.

3.B.3. (S//REL) **PHASE III: SEARCH AND ATTACK PHASE.** (O/A 01 AUG 07 TO 31 AUG 07). FOLLOWING THE KINETIC SHAPING OPERATIONS IN PHASE II, THE JSOA WILL BE DEACTIVATED AND THE QUARRIES AREA (SEE ATT 1) WILL FALL UNDER THE AUTHORITY OF MNF-W (THE MAIN EFFORT). MNF-W WILL CONDUCT SEARCH AND ATTACK OPERATIONS TO KILL/CAPTURE AQI, REDUCE CACHES, CLEAR ROUTES OF IEDS AND PREPARE THE TERRAIN FOR HANDOVER TO HOLDING FORCES. MND-N AND MND-B CONTINUE CONTAINMENT OPERATIONS IN ORDER TO PREVENT WITHDRAWAL OF ENEMY FORCES.

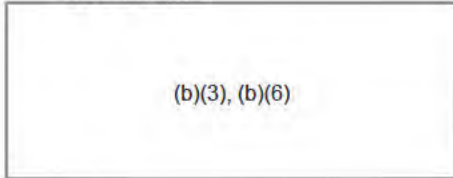
