THIS OPERATION IS A SUPPORTING EFFORT TO OPERATION DEFEAT AQI IN THE NORTH (DAN).

ALL PHASES OF THE OPERATION. THIS PHASE ENDS WHEN WE CONFIRM TARGETS WITH SUFFICIENT ACTIONABLE INTELLIGENCE OF BOR AQI THREAT FINANCING NETWORKS, LOCS, SUPPORT ZONES AND SANCTUARIES.

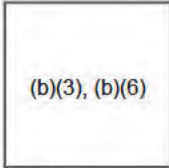
