WARPLANS:

1. TOPIC: 20 BCT ENHANCEMENTS (Status – Update)

DISCUSSION: FRAGO 410, Multi-National Division-Center Integration was published on 17 MAR 07. The FRAGO spells out the staff and MND responsibilities for integrating the new division into MNC-I. This week as well the MNC-I Commander was presented a briefing on the Baghdad Belt and options for employment of 4/2 SBCT and 2/3 ID. The decision was made by the Commander to base 4/2 SBCT at Taji, however, he retained two options. The first is to employ the Brigade minus as an Operational Reserve and reinforce Tarmiyah and Baquba with two battalions. Option 2 would see 4/2 SBCT committed to its own operational environment southwest of Baquba along the North/South threat lines of communication from Baghdad to Baqubah and Hussiniyah to Baqubah, as well as the lateral AQI LOC from Tarmiyah to Baqubah. Further he decided 2/3 ID headquarters and two battalions will deploy to MND-B, a third battalion will deploy to MND-Center and the artillery battalion will round out the Theater Security Brigade whose third maneuver battalion is presently supporting 2/82 ABN in Baghdad. Both 3/3 ID and 3ID remain on track to be fully operating capable on schedule.

NEXT ACTION: A PLANORD has been drafted for employment of 4/2 SBCT which is preparing to be sent out that will direct MND-B and MND-N to plan for the 4/2 SBCT employment options described above. The MNC-I staff will continue to refine the Commander's options.

3. TOPIC: MNC-I CAMPAIGN PLAN DEVELOPMENT (Status – Update)

DISCUSSION: The Bridging Operational Concept and Operational Overwatch, two topics from last week's notes, have been incorporated into this new topic. Recently, the Commander's Initiatives Group prepared a document entitled "MNC-I Coalition Campaign Operational Concept," which was briefed at the Joint Plans Group meeting on 8 Mar 07. C3 Plans & Policy will develop an MNC-I campaign plan based on this document. This process will be done in parallel to the MNF-I effort. On 21 Mar 07, MNF-I stood up a Joint Strategic Assessment Team (JSAT) to assist with the development of a revised campaign plan. This group has the tentative goal of developing a product by late April.

NEXT ACTION: Develop more refined concepts for Phase III (Tactical Overwatch) and Phase IV (Operational Overwatch) of the MNC-I Campaign Operational Concept. Attend initial sessions of the MNF-I JSAT to stay abreast of and help shape higher headquarters efforts.

4. TOPIC: INFRASTRUCTURE SECURITY STRATEGY (Status – Change)

DISCUSSION: MNC-I has begun parallel planning with MNF-I as we attempt to address the security issues and concerns of oil and electrical infrastructure in Iraq. Planners are participating in a number of MNF-I working groups in order to better understand the relationship between the attacks and the effects on the ability of infrastructure to deliver energy both oil and electricity to the populace as well as government wealth generation. MNF-I have apprised C3 of their current line of development as they refine their Infrastructure organization. Plans completed the cost/benefit analysis of protecting three corridors (Kirkuk-Bayji, Bayji-Baghdad, and Baghdad South-Mussayib). A meeting, attended by COS Iraqi MoD, DCG MNF-I and CG MNSTC-I, was convened to discuss the SIB report. Regrettably, there was little reference to the report and it was decided that MNSTC-I would produce a memo for the PM at the next IPC outlining a series of measures to train and equip some 3000 jundi who were not trained in 06. In addition, a joint CF/Iraqi group would be formed (lead by MNF-I SRATOPS LAPD) to take issues forward. In separate developments IGFC have been tasked with convening an Infrastructure Security conference before 15 Apr 07.

6. TOPIC: BORDER SECURITY (Status – No Change)

DISCUSSION: Following a three day closure of POEs with Syria and Iran, the GOI reopened POEs on these borders with the exception of AL Qaim on the Syrian Border (which is still under construction) and Zurbatiyah and Al Sheeb on the Iranian border (which require improvement to their infrastructure before being in position to resume normal operations).

While focused POE training will add to border security, many issues remain unresolved. On a positive note, the DBE and MOI continue to engage the IA and MOD to work out the details of tactical and operational integration in accordance with the recently signed "All Regions MOU". Although this MOU mentions the "partnership" role played by CF in border security, the details of how CF interacts with Border forces now that MNC-I no longer has TACON of DBE units remains unclear. The DBE continues to have difficulties in raising their TRA status particularly in the areas of supply and maintenance. This is partially due to their low priority for receiving equipment and partially to their inability to cross-level or maintain property accountability. Increased enforcement of standards at the POEs is anticipated to increase illegal cross-border activities at other unofficial border crossing sites. While DBE forces conduct some patrolling and interdiction between border forts, this is limited by available fuel and other factors. MNC-I is exploring options to increase CF presence at the borders, but the priority of Baghdad security operations make any large scale increase unlikely. MNC-I continues to refine mission analysis on overarching border strategy to nest with MNF-I FRAGO 07-035, Securing the Border Strategy 2007, 21 JAN 07.

7. TOPIC: LNKG OPERATIONAL BASING TO CAMPAIGN PLAN (Status– No Change)

DISCUSSION: Currently attempting to link operational basing to the campaign plan. Intent is to establish the selection criteria and validate what the final set of bases will be as coalition forces draw down and eventually move to strategic overwatch. This effort is critical to the campaign plan since the basing of coalition forces will directly impact operational freedom of maneuver.

NEXT ACTION: Evaluate the bases that have been identified as the final set, determine what criteria was used to select these bases, and if these bases maintain their relevancy given the changing environment in OIF and regional considerations.

8. TOPIC: BASE CONSOLIDATION AND CLOSURE (Status – Update)

Discussion: in the ongoing efforts to turn over battle space to the ISF, MSC close or transfer bases to either MOD or MOI under a “condition based” approach. Base transfer / closure is driven by three major considerations: stability in the AO, ISF ability/capability to assume & hold battle space and funding for base consolidation. The current methodology is bottom-up driven with MSC nominating bases for transfer/closure, gaining approval, and following a 100 day notional timeline, which serves as a guide to accomplish necessary steps in the transfer/closure process.

Next Action: all base transfers/closure nominations have to be approved by CG; the 3ID CAB will operate out of BIAP and basing at Stryker; pending final decision on 4/2 SBCT employment. [redacted] 1.4b, 1.4d basing options are Camp Delta / MND-CS or Base Normandy, Caldwell, and Warhorse / MND-N; initial assessment on basing options submitted. HQ consolidation and IZ Transition most likely shift to the right; VBC Garrison continue planning for GRD, CSH, 1x BN from 4/1, 1x BN from 3/3, 3ID DIV HQ, 4/2 SBCT and [redacted] 1.4a pax from MNF-I; awaiting decision on 2/3 and [redacted] 1.4b, 1.4d

9. TOPIC: ISF OPCON AND TRANSITION OF IA DIVISIONS (Status – No Change)

DISCUSSION: The Baghdad Operations Command (BOC) was established under the authority of Prime Minister Maliki in accordance with Prime Minister Letter 4/2/1 (amended by Executive Order (1)) dated 2 Jan 07. This initiative directed all Baghdad-based Iraqi Security Forces (ISF) to be directly transferred OPCON to the newly established BOC on 1 Mar 07 under the command of LTGEN Abud Kanbar Hashim Khayun al-Maliki. An MOU between MNC-I and BOC has been produced to provide

further direction and guidance on the detailed roles, responsibilities, and relationships of the various Iraqi and Coalition Force elements conducting security operations within the BOC AOR to ensure that the Prime Minister's intent could be met.

The BOC AOR consists of the ten Administrative Districts, referred to as Security Districts, and is extended to include the areas under control of the 6IA and 9IA divisions that fall outside of the ten security districts. Within Baghdad, the BOC AOR is further subdivided into two sectors: the Al Karkh sector (west of the Tigris River) and the Al Rasafa sector (east of the Tigris River). The HQ in each of these two sectors controls Iraqi Security Force tactical operations within their respective sectors.

As such, on 1 Mar 07, the BOC assumed OPCON of 6IA and 9IA Divisions, 1NP and 2NP Divisions and other ISF elements based in Baghdad.

10. TOPIC: BORDER SECURITY (Status – No Change)

12. TOPIC: IA LEGAL ADVISOR PARTNERSHIP PROGRAM (IALAPP) (Status – Update)

DISCUSSION: The MNC-I OSJA IALAPP stated priorities are: (1) Oversee IGFC Legal Advisor training; (2) Clarify IA powers of arrest for all IA elements subject to different C2 arrangements; and (3) Encourage centralized IGFC Detainee procedures and policies.

NEXT ACTION: Ongoing projects include:

- Replacement of BG Mohammed, who passed away recently from cancer. (b)(6) [redacted] the 6IA Division Legal Officer has been nominated, and has reported to the IGFC at MOD;
- Training IA Legal Advisors on the recently passed Military Procedure Law and Military Penal Code (together, the new Iraqi Armed Forces Military Justice system); MOD training for 28 new Legal Advisors should be complete on 30 March. MOD will train existing Legal Advisors in April;
- Continue training on IA ROE including an information paper, PowerPoint training slides, and ROE Cards;
- Working with MNSTC-I on formulating proper Detainee SOPs and policies;
- Currently working on agreements with DOJ, DOS, and GOI for all future Tiger Teams of investigative judges in MND-B, MND-N, and MNF-W, and working on internal MNC-I SOP for conducting the operations;
- All remaining computers delivered to IA Legal Advisors.

13. TOPIC: ELECTIONS (Status – UPDATE)

DISCUSSION: On 23 January the Council of Representatives (COR) passed the law establishing the Iraqi High Elections Council (IHEC). The IHEC will establish the governing body for national and provincial elections in Iraq. The IHEC is also responsible for conducting the referendum in Kirkuk regarding TAL 58 and Article 140. The passing of the IHEC law starts a 60 day clock to nominate and assign council members. The UN is taking the lead on a 120 day training program for council members and their staffs. The USAMB is expected to make a recommendation to PM Maliki by the end of March 2007 on whether provincial elections should be held in CY 2007. If so, recommendation is expected to be November 2007 at the earliest. The logical next step would be to conduct a national census; the last one being held in 1990. It is reasonable to assume that there are some in the GOI who stand to lose power in an election and will attempt to postpone the Provincial Elections until January 2009 when the National Elections are next scheduled to occur. Presently, sub-provincial elections cannot occur.

14. TOPIC: UNAMI SUPPORT (Status – Update)

Discussion: UNAMI withdrawal from the Basra : UNAMI will remove its moveable stores and equipment from Basra Palace in the last (fourth) week of Apr 07. Only remaining UNAMI assets in BP after end Apr 07 will be buildings and infrastructure (generators and water treatment plant), these being used by US REO (Regional Embassy Office). As a result of this, UNAMI will have no further need for the ROM CO. Draft letter from UNAMI to GOR with COS UNAMI outlining above.

UNHCR mission to Karama Trebil BCP on 25 Mar 07: MNF-W will provide QRF, MEDVAC and personnel recovery to UNHER party if required.

UNAMI electoral affairs visit to Sulaymaniyah on 3 Apr 07: MND-N/NE will provide QRF, MEDVAC and personnel recovery for UNAMI team during travel within their battle space

15. TOPIC: OPERATIONAL REVIEW OF CURRENT GLOCs (Status- New)

DISCUSSION: Currently reviewing A/GLOCs and analyzing options for reducing MNC-I dependency on a primary GLOC. Intent is to ensure that from an operational perspective MNC-I has maximized potential for redundancy and flexibility in support of current and future operations.

NEXT ACTION: Continue to explore options for increasing secondary A/GLOCs given the current operational environment.

ISF:

1. TOPIC: AL ANBAR POLICE TRAINING (Status - Update)

DISCUSSION: MNF West has two months before a new police academy can be opened in Al Anbar (predicted not earlier than 19 May). Alternative arrangements were made to maintain the flow of trained recruits until the academy is opened. On 24 FEB 250 recruits began training at the Mosul Public Safety Academy (MPSA). FRAGO 401 (DTU Task #3) directed transportation and security support for a second MPSA 8 week class of 250, and two 500 student classes were added at Sulaymaniyah Joint Training Academy (SJTA). The first of these SJTA classes began 25 March and the second class starts 08 April. CPATT has successfully coordinated these classes for MNF West and MNCI.

NEXT ACTION: Track movement for 2 x 250 Basic Recruit Trainees (BRT) classes at Mosul. Track movement for 2 x 500 BRT classes at Sulaymaniyah.

2. TOPIC: AL ANBAR EMERGENCY RESPONSE UNITS (Status – Update)

DISCUSSION: On 15 March '07 PM Maliki approved the Anbari Deputy Governor's request for an eight (8) battalion based ERU in Al Anbar. This legitimizes the ERU as an ISF under CPA Order 91. The order dictates any type paramilitary organization must have GOI approval and be assigned to the MOD or MOI as an ISF. MNF-W assigned 3 Infantry based PTTs to the ERU for unit level training. MNF-W will establish training curriculums and class schedules utilizing PTT injections, eventually transitioning the academy to IP control. Currently approximately [redacted] 1.4a are formally trained. MNF-W and CPATT transferred IP training equipment from the Jordanian International Police Training College to Camp Habbaniyah for academy start up. Planning is still in the initial stages for the training of the ERU.

3. TOPIC: BORDERS POE ROLES AND RESPONSIBILITIES (Status – Update)

DISCUSSION: New maintenance contract for ZVB Backscatter Vans was signed 06 Mar 07 and is expected to be finalized 26 Mar 07. Projected arrival date for contracted maintenance teams is 15 May 07. The contract is expected to include a sustainment plan written to transfer over to MOI. The sustainment plan will include training for maintenance and field service engineer technicians. There are 7 of 30 Backscatter Vans reported as non-operational for this period. DBE remains without a dedicated POE Director, since the assassination of MG Emad Mohsen Al Shaheen. BG Faroud is now the acting National POE Director. A permanent POE Director is needed to make lasting change IAW CF objectives across all POEs in Iraq. If appointed soon, a new POE director will be the ninth in the last 24 months. Lack of a National Director degrades accountability of regional POE directors resulting poor operating standards abroad. DHS will maintain a 12 man BST coverage of Iraq with 2x man teams (per) in support of MND- N, MND-CS, MND-SE and MNF-W. A 3-man team will remain in Baghdad to rove to various POEs and support MOI TT with policy development. MNC-I (IAG) will receive one agent to provide SME support and assist in border security operations. DHS is seeking to extend BST from current 90 day rotations to 120 days. Additionally, DHS is expected to receive up to [redacted] 1.4a contracted border agents NLT June 07 to enhance POE coverage and augment both the current BST and TT.

4. TOPIC: BORDER SECURITY (Status – Update)

DISCUSSION: CPATT conducted a POE Enhancement meeting with MG Mohsen (DBE Cdr) on 17 Mar 07 that will lead to significant POE infrastructure improvements for Zurbitia, Shamalmcha and Bashmakh POEs & (minor improvements to Muntheria and Reba). Baggage scanners (2 per POE) will be purchased in support of POE operations. The GOI is currently considering plans to re-align Airports and Seaports from MOT to MOI under the control of the DBE. Centralized control of Land, Air and Seaports will help to improve progress of DBE control of Iraqi Border security. MNF-I STRAT FUOPS will continue planning on Umm Qasr Sea port. The purpose is to review initial mission analysis and initial draft COAs, tied to conditions regarding security and C2 of sea and airports. This will lead to developing and OPLAN, not necessarily an OPORD. MOD, MOI, DBE and CF began planning early Feb to synchronized array of forces to facilitate and operationalize MOU objectives. The "All Regions MOU" is written to expand integration initiatives for border security on the strategic level in all DBE Regions.

5. TOPIC: NATIONAL POLICE (Status – Update)

DISCUSSION: New 'Askariya Bde' currently is being established to protect reconstruction of the Al-Askari Mosque, Samarra. Initial training commenced 18 Feb 06 at Al Hilla IP Academy. Basing to be PB Olsen for Bde HQ, and an extension is to be constructed at FOD Uvanni to house the BNs. 3-3-1 BN is no longer being considered for transfer to the new Bde, and will return to Baghdad on or around 28 Apr 07.

Askariya Bde forecast to be IOC 31 May 07, FOC Sep 07 but problems remain in recruiting suitable officers. This new Bde are to receive 20x UAH HMWVs, although it is unclear as to how they are to be employed by the NP. This will be the first NP unit to have operated HMWVs. 2nd Bde returned to Numaniyah to complete re-blueing training following their involvement in operations supporting Arbaeen; they will now graduate on 25 Mar 07. 7 Bde NP are next to attend re-blueing, from 2 Apr-2 May 07.

6. TOPIC: EQUIPMENT/LOGISTICS SUPPORT TO BRIGADES REINFORCING BAGHDAD SECURITY (Status – Update)

DISCUSSION: Continuing to over-watch high priority equipment sustainment issues for IA units coming to Baghdad as part of Farhd Al-Qanoon. 1/2 & 1/1/2 have requested a small amount of IBA's and Helmets, along with other equipment that is being expedited via Iraqi channels through IGFC written correspondence to JHQ and MOD. 2nd division units that are now in Baghdad, have picked up their 27 - 5 Ton trucks and 10 shot guns as part of their Force Generation equipment. Working with MITTs on 2nd round of units coming to Baghdad to see if any urgent equipment requirements are identified.

8. TOPIC: ISF FORCE GENERATION (Status – Update)

DISCUSSION: The 30K soldier expansion plan continues and is currently at the end of the third iteration. This plan addresses the average of 1,500 soldiers lost per month (casualties, DFRs, and AWOL) as well as brings all units to 110% strength. To date, an approximate total of 14,800 of the 30K have been recruited and trained; of the 14,800 recruited and trained 7,820 IA Jundi have been distributed and received by the IA Divs. The third iteration is on going with an approximate 8500 IA recruits currently in training. The third iteration is scheduled to end the week of the 20th thru the 29th of March.

The IA force generation process is focused on the Prime Minister's Initiative Force. The soldiers currently in basic training at the 1st, 2nd and 3rd ITB are currently prioritized to go to 11th Div HQ and 4/9 IA. 11th Div HQ is scheduled to begin fill on or around 1 April, which will be the MP and Sig CO primarily. The soldiers of the 4/9th IA will begin fill 1-21 April from 3 graduating classes.

Two HR Companies were programmed and resourced for 07-09 based on a 13-BCT set and associated enablers. Iraq AOR failed to ramp off units as forecast, and added forces which overlap into 07-09. Additional command and control HQs are needed to manage these assets. Total 1.4a personnel.
