RMKS/1. (8)-MR. SECRETARY, IN RESPONSE TO YOUR TASKERS CONTAINED IN THE MEMOS OF 21 APRIL 03, I AM DOING THE FOLLOWING IN AFGHANISTAN AND IRAQ CONCERNING DETAINEE CONTROL.

2. (S) IN IRAQ, WE HAVE ESTABLISHED AN AGGRESSIVE RELEASE/PAROLE PROGRAM OF THOSE DETAINEES WHO ARE NOT CONSIDERED A THREAT AND WHO HAVE NO EXPLOITABLE INTELLIGENCE VALUE. AS OF 08 MAY 03, WE RELEASED 3.863 INNOCENT CIVILIANS, PAROLED 3.790 EPWS, AND HAVE 1.754 DETAINEES ON HAND. TO DATE 78% OF THE TOTAL NUMBER OF DETAINEES ALREADY HAVE BEEN REPATRIATED. IN THE FUTURE, AS THE NEW IRAQI

3. (S) AFGHANISTAN POSES A DIFFERENT CHALLENGE. AS OF 16 JUNE 02, WE NO LONGER WILL SEND LOW-LEVEL COMBATANTS WHO POSSESS NO EXPLOITABLE VALUE TO CAMP DELTA, GTMO. I WILL TRANSFER THOSE DETAINEES AT THE FIRST OPPORTUNITY, TO THE CUSTODY OF THE AFGHAN GOVERNMENT. IN ORDER TO CARRY OUT THIS POLICY, IT IS ESSENTIAL THAT APPROPRIATE AGREEMENTS ARE REACHED WITH PRESIDENT KARZAI AND AN ACCEPTABLE AFGHAN DETENTION CAPABILITY IS QUICKLY ESTABLISHED. THE SHORT TERM DETENTION FACILITY AT BAGRAM WILL REACH ITS CAPACITY BY THE END OF THIS CALENDAR YEAR WITH LOW LEVEL DETAINEES KEPT IN AFGHANISTAN RATHER THAN TRANSFERRED TO GTMO. THE PRIMARY RESPONSIBILITY FOR NEGOTIATING THE APPROPRIATE AGREEMENTS AND ESTABLISHING DETENTION CAPABILITIES LIES WITH THE DEPARTMENT OF STATE, AS YOUR 21 APRIL 03 MEMORANDUM TO THE SECRETARY OF STATE PROVIDES. LTG MCNEILL AND I WILL ENGAGE PRESIDENT KARZAI TO REINFORCE THE IMPORTANCE OF THIS EFFORT AND WILL RENDER ASSISTANCE TO THE AMBASSADOR AS REQUIRED TO MEET YOUR INTENT.
