# CJTF 1.4a CCIRs FFIR

- 1. Change of Status/Attack/Sabotage/Looting on power grid (Electrical Power/Dams/Sub-stations/Lines)
- 2. Change of Status/Attack/Sabotage/Looting on pipeline(s) (Oil/LPG) or oil companies
- 3. Presumptive or initial indication of 1.4a Program information
- 4. Attack on CPA Facilities or Personnel
- 5. Change of MSR/ASR Status (Blockage/Condition/Trafficability)
- 6. Assassination/attack/kidnap or attempt on leadership (Iraqi/Coalition/CPA)
- 7. Attack on commercial convoy
- 8. Change in Status of regional stability (permissiveness)

# CJTF 1.4a CCIRs

## FFIR

- 9. Capture or surrender of Iraqi GO, Senior Iraqi Government Official or Blacklist top 20
- 10. Loss of Coalition Soldiers (mass casualties, 3x or more)
- 11. Capture/Engagement of Non-Iraqi Forces
- 12. Possible/Confirmed Friendly Fire Incident
- 13. Disruption or interference of routine operations and distribution of vital supplies (Humanitarian Assistance, LPG, Medical Supplies, etc...)
- 14. Infraction of ROE or any event that may illicit an adverse political, media or international reaction (cross border; foreign figure/leader arrest; attack or arrest against a coalition or allied element)
- 15. Contact resulting in significant civilian casualties

10. (U) PIR: CJTF <sup>(1,4d)</sup> **COMMANDER'S RECOMMENDED PIR'S**

(1) ~~(S//REL TO USA and MCFI)~~ Who is directing, facilitating, and conducting attacks against the Coalition, the Iraqi people and their interests and where are their bases of operation (FRE, terrorist, Mujahedin, Shiite, etc.)?

(2) ~~(S//REL TO USA and MCFI)~~ How and by whom are the foreign fighters being recruited, positioned, and tasked to support FRE and terrorist organizations?

(3) ~~(S//REL TO USA and MCFI)~~ Who are the saboteurs against infrastructure and where will they attack?  
Status: Amber

(4) ~~(S//REL TO USA and MCFI)~~ What actions/activities will hinder the coalition's efforts in rebuilding Iraqi capacity and the Iraqi Governing Council from assuming civil and military authority?

(5) ~~(S//REL TO USA and MCFI)~~ Which tribes/tribal, religious, political and community leaders should we engage as partners and which are acting against Coalition and Iraqi interests?

(6) ~~(S//REL TO USA and MCFI)~~ Who are the groups/organizations/individuals (FRE, <sup>(1,4b, 1,4d)</sup> tribal) involved in or sponsoring criminal activity designed to undermine support to the coalition or coalition-backed Iraqi officials?

(7) ~~(S//REL TO USA and MCFI)~~ Where are the most urgent/critical humanitarian crisis area (food, water, power, fuel, medical, unemployment) that require humanitarian assistance?
