USAHEC Copy Center services include reproduction of most books, manuscripts, microforms, photographs, and film held in our collections. There are fees associated with each type of reproduction; payment must be made in advance in the form of a credit card transaction (Visa or MasterCard,) check or money order **made payable to MHI Fund**, or a bank funds transfer. Banking information will be provided upon request.

Foreign patrons must pay using U.S. currency, and in a form that will clear through U.S. banks.

Checks returned for insufficient funds will entail a \$25.00 processing fee in addition to the cost of the original order.

Associated fees for types of reproduction are listed below for informational purposes only (note prices are subject to change.) Each request is unique so we ask that you submit a request by email or in writing for all reproduction services; a quote will be provided with instructions on how to proceed. Please include as much identifying information as possible with each request.

Below are the fees associated with the different types of reproduction services offered:

1: REQUEST FOR REPRODUCTION OF PHOTOGRAPH(S)

We reproduce photographs either, as a high quality digital scan emailed to the patron, or as a black and white digital print mailed to the patron via USPS. Photographs not previously digitized are scanned at 600 dpi and saved in jpeg or tiff format. Photographs may have been previously scanned at only 300 dpi or 400 dpi; if the patron requires a new scan of this particular photograph, the fee for this service will be as a non-digitized photograph.

2: REQUEST FOR REPRODUCTION OF PRINTED MATERIAL

[NOTE: For offsite requests, we provide either a photocopy that will be mailed to the patron via USPS, or send the reproduction electronically by email (or FTS if too large a file) in pdf format. Also, large orders for Foreign Patrons will be reproduced as a scan only.]

- 1) Onsite, self-service reproduction fee is \$0.25 per page.
- 2) Onsite Copy Staff reproduction fee is \$0.50 per page.

3) *Non-Digitized Material for Offsite Patrons*

- a) Fee for photocopy reproduction:
 - 1 - 5 pages \$5.00
 - 6 – 12 pages \$10.00
 - 13 – 23 pages \$20.00
 - 24 and over pages \$0.80 per page
 - Oversized material is \$1.50 per image
- b) Fee for 300 dpi scan reproduction:
 - 1 to 10 pages \$10.00
 - 11 to 20 pages \$20.00
 - 21 to 30 pages \$30.00
 - Over 30 pages \$1.00 per page
 - Oversized material is \$2.00 per image
